2. WHEREAS each of the parties hereto of the "Party of the Other Part" has individually and jointly agreed to act as Trustees of the Trust, proposed by the party of the first part.

3. WHEREAS the party hereto of the first part is possessed of the sum of Rs. 50,000/- (Rs. Fifty Thousand only) hereinafter referred to as his absolute property and he is desirous of creating a Charitable/ Educational Trust for the benefit of the humanity at large.

4. WHEREAS the Settler of the Trust desires to irrevocably endowing the said funds upon trust for educational purposes, as hereinafter expressed and contained in this presents and in pursuance of such desire have already transferred paid and handed over the said property to the "Party of the Other Part" (trustees) mentioned above.

5. WHEREAS the trustees shall stand possessed of the said amount of corpus endowed by the Settler of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

6. WHEREAS it is the desire of the Settler of the Trust that the Corpus of the Trust may be further augmented from time to time by flow of funds and other assets including moveable and immovable and any other kind by way of gifts, or donations, acquisitions, allotments, grant exchange or otherwise etc.

7. WHEREAS nothing contained in this deed shall be deemed to authorize the trustees to do any act which may in any way be construed statutory modifications thereof and all activities of the trust shall be carried out with a view to benefit the public at large, without any profit motive and in accordance with the provisions of the Income-Tax Act, 1961 or any statutory modification thereof.

8. WHEREAS the trust shall be an irrevocable educational trust for the benefit of the persons belonging to all strata of society, irrespective of community, caste, creed or Religion.

9. AND WHEREAS the trust is hereby expressly declared to be a public charitable trust and all the provisions of this deed are to be constituted accordingly.

NOW THIS INDENTURE WITNESSTH AS FOLLOWS :



- e) To establish run, maintain Libraries, Reading rooms for public use to conduct training classes, seminars for benefit of the community in general.
- f) To establish run, maintain training institutions/ centres; teachers' training institutions and research & training centres for the furtherance of cause of education/ learning in the society.
- g) To acquire and maintain the movable and immovable properties by outright purchase or on lease or on Build-Operate-Lease & Transfer (BOLT) basis for achieving the said objects.
- h) To undertake any other activities incidental to the above activities but which are not inconsistent with the above objects.

13. **PRESIDENT :**

Raj kumar Singh will be president of the trust nominated by the board of Trustees who will look after the administration of this trust.

14. **MANAGING TRUSTEE :**

The day-to-day administration of the Trust shall be looked after by the **Shri Kamal Kumar S/o Mahendra Prasad Singh**, Managing Trustee, under the guidance, control and supervision of Board of Trustees. The Board of Trustees shall nominate one amongst the trustees, who shall hold office for such period, as may be decided by the Board of Trustees. The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.

15. **TREASURER:**



Shri Manish Chandra Roy will be Treasurer of the trust nominated by the board of Trustees who will look after the maintenance of books of accounts and Bank operation of this trust

16. NUMBER OF TRUSTEES/VACANCIES :

Apart from Settler trust will have a minimum of three trustees. If at any time the number of the trustees is less than three, the Board of Trustees shall appoint one or more trustees. Upon the appointment of a new trustee the trust properties shall vest in the new trustee jointly with the continuing or surviving trustees, with the duties and power of the trustees set out hereinabove in this deed.

17. MEETING AND PROCEEDINGS OF THE TRUSTEES :

The Trustees shall ordinarily meet once in three months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust. In case of any difference between the trustees, the opinion of the majority shall prevail.

18. TERMINATION/ APPOINTMENT OF THE TRUSTEES :

(a) Trustee shall cease to hold office ;

- i) if he/she dies,
- ii) if he/she resigns,
- iii) if he/she is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv) If he/she is found to have acted against the interest of the Trust., if it is unanimously decided by the Trustees that his continuation in the Office is against the interest of the Trust.



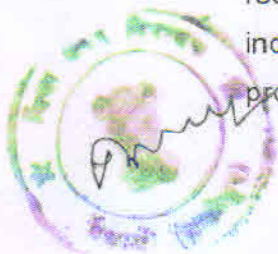
- (b) Any of the trustees may retire on giving one month's notice in writing to the other trustee(s).
- (c) If any trustee dies or retires or becomes incapable or unfit to act, the continuing or surviving trustee or trustees shall appoint a successor in the place of such trustees.

19. POWER OF TRUSTEES :

That the trustees shall have the following powers :

- (a) To manage all the assets and/or properties of the trust including the conduct of business;
- (b) To appoint employees and to settle the terms of their service, remuneration and termination;
- (c) To look into the management of the trust;
- (d) To invest the funds of the trust, in bank or in the purchase of company shares or securities or other movable and immovable properties;
- (e) To sell, alter, vary, transpose or otherwise dispose or alienate the trust properties or any investment representing the same for consideration and to reinvest the same;
- (f) To pledge or mortgage the trust properties of raising loans;
- (g) To open the bank accounts in the name and on behalf of the trust and to operate the same;
- (h) To enter into a partnership on behalf of the trust with any other party or parties;
- (i) To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;



- (j) To file suit on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed;
- (k) To accept any gift, donation or contribution in cash or in kind from anyone for the objects of the trust;
- (l) To seek legal opinion of lawyers and/or Chartered accountants as and when required; or to nominate representatives for any of the aforesaid purposes.
- (m) Every trustee will be at liberty to nominate or appoint attorneys or agents and to delegate all or any of the duties and powers vested in him to such attorney or agent, and to remove such attorney or agent and reappoint other or others in his place.
- (n) No trustee shall be responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his willful neglect or default.

20. **FUNDS :**

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter.

21. **INVESTMENTS :**

- (a) All monies, which shall not immediately required for current needs shall be invested by the Trustees in eligible securities and



investments as notified by government of India, or in scheduled banks. Such investments shall be in the name of Trust.

- (b) That the trustees shall invest the trust fund, conduct business with the trust fund and/or enter not partnership on behalf of the trust, as they may deem fit as per objects of the trust.
- (c) That the trustees shall manage the trust fund and investments thereof as a prudent person would do the same. They shall recover all outstanding dues and meet all recurring and other expenses incurred for the upkeep or management thereof.
- (d) That the trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries of the trust.

22. **BOOK ACCOUNT :**

- (a) The Board of Trustees may open such Bank Account or accounts in any of the Banks in the name of **Anamika Educational Trust**. The President and Managing Trustee or any other Trustee shall jointly operate such accounts.
- (b) The trust may also open Bank Account/s in the name of institution/ organization founded by the Trust. These Bank Accounts shall be operated by such persons, as authorized by the board of trustees from time to time.

23. **APPLICATION OF THE PROPERTIES OF THE TRUST :**

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any temporary remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.



24. **DEFECTS OF PROCEDURE IMMATERIAL :**

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.

25. **AMENDMENTS :**

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11,12 and 13 and 80G of the Income Tax Act,1961 as amended from time to time.

26. **BANKING ACCOUNT :**

All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any scheduled bank for the purpose of the Trust. These bank accounts shall be operated by the **Managing Trustee** along with **Shri Manish Chandra Roy**, Treasurer of the trust.

27. **ACCOUNTS AND AUDIT :**

The Trustees shall keep proper books of account of all the assets, liabilities and maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust and shall prepare as Income and expenditure Account and Balance Sheet for every year as on the last day of March. The accounts shall be audited by a Chartered accountant or a firm of Chartered accountants, who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.

28. **IRREVOCABLE :**

This Trust is irrevocable.

29. **DISSOLUTION/ AMALGAMATION/ WINDING UP :**

In the event of dissolution or amalgamation or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to some other similar Trust/ Organization, whose objects are similar to those of

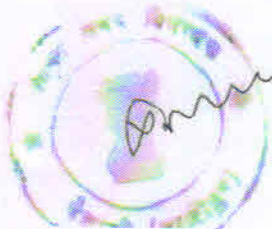
